Minutes of the Customs Clearance Facilitation Committee Meeting (CCFC) held on 20.08.2018 at 04:00 P.M in the Board Room of Custom House, Kolkata

The Customs Clearance Facilitation Committee Meeting was held in the Board Room of Custom House, Kolkata on 20.08.2018. The meeting was presided over by the Chief Commissioner of Customs, Kolkata Zone, Kolkata.

The Chief Commissioner of Customs, Kolkata Zone welcomed all the members. He also stated that "Action Taken Reports" on the points discussed in the previous meeting should be placed before the meeting. Accordingly, the Dy. Commissioner, Appraising General Unit, stated the actions taken on the points discussed in the previous meeting held on 23.07.2018.

Review on the points discussed in the CCFC meeting dated 23.07.2018:

 At present, there is no permanent officer in the office of Wildlife at Airport cargo complex. So, for emergency, samples need to be taken to Wildlife office at Nizam Paiace for examination which is risky regarding safety and cause demurrage.

The representative of WLA informed that about 500 shipments are received by WLA every month for clearance but out of those cases, only around 20 shipments are coming for online clearance which are related to cattle horn, shell and medicinal shipments. The Commissioner (A&A) asked if WLA is part of SWIFT. In view of the number of samples sent to WLA from Air Cargo Complex being quite high, the Chief Commissioner stated that one officer needs to be present at Airport at least twice a week as per the earlier prevailing practice. The representative informed that WLA doesn't have SWIFT connectivity in Air Cargo Complex.

The Chief Commissioner observed that these problems need to be addressed at the earliest. Shri Sudip Dey, Vice President of CCHAA stated that certain items are not mapped in SWIFT and hence those samples are coming to WLA for manual clearance. The Commissioner (A&A) was advised to take up the matter with the appropriate authority for posting of WLA representative at ACC and also look up and also look into the issue of not all items getting covered with SWIFT.

Following issues were discussed in the CCFC meeting dated 20.08.2018:

1. The representative of Textile Committee informed that there is a pendency of Rs. 3,24,000/- as test charges from groups and SIB.

The Commissioner (A&A) stated there should be a CHA and importer wise list from which the defaulters may be identified and the charges may be recovered from them. The Chief

Commissioner stated that the DC, Group-III should take action on this matter on an urgent basis. However, CCHAA members should also take proactive approach in this matter and discuss with the concerned importers and CHAs to resolve the matter as soon as possible.

It was also observed that if no action is taken from the Customs Brokers' end to clear the pendency in payment of test charges, actions will be taken against the defaulters under the provisions of CBLR.

The representative of plant quarantine informed that few Bills of Entry are not getting redirected to plant quarantine system and those Bills of Entry got cleared without the NOC from PQ.

In this regard, the Chief Commissioner observed that all related Bills of Entry should go to PQ for NOC unless exempted by RMS system.

The Chief Commissioner stated that all members of CCFC committee should attend the meeting without fail.

The next date for CCFC meeting has been fixed on 24.09.2018 at 4 p.m.
